


Original digital sketch of The Ritz-Carlton Residences. South Beach by architect Kobi Karp.




The revitalization of the Sagamore by Studio Munge respects the hotel's mid-century DNA while seamlessly expanding on it in a way that is unmistakably contemporary.










Karp used full-height crystal-clear glass panels and expansive private balconies to create residences that give the feeling of being suspended in space between sand, sea, and sky.
